- 5. That school is not paying any charges towards using name, motto, logo or any other non – academic activities to any other institution, organization or body.





- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time.
